



**BAC Resolution Declaring Single Rated and Responsive Bid (SRRB) and Recommending Award for the Procurement of "Tourism Destination Marketing Company for Middle East/Gulf Cooperation Council" (DOT-BAC REI No. 2020-002)**

**Resolution No. 2020-119**

**WHEREAS**, pursuant to approved Department of Tourism (DOT) Bids and Awards Committee (BAC) Resolution No. 2020-111 dated 25 June 2020, **Durga Das Publications (Middle East) FZE**, being the Single Rated Bidder (SRB) for the "Procurement of "Tourism Destination Marketing Company for Middle East/Gulf Cooperation Council", was invited for the Opening of the Financial Proposal and Negotiation on 08 July 2020 pursuant to the Competitive Bidding Procedures – Quality-Based Evaluation (QBE) provisions of Republic Act No. 9184 (RA 9184) and its 2016 Implementing Rules and Regulations (IRR). A copy of the approved BAC Resolution No. 2020-111 and the Invitation to Negotiate and Opening of Financial Proposal sent to the SRB for Middle East/Gulf Coop Council are hereto attached, marked as **Annex "A"** and **Annex "B"**, respectively, and are made integral parts hereof;

**WHEREAS**, the Opening of the Financial Proposals had the following result:

**WHEREAS**, after having successfully completed the negotiation, the Bid of Durga Das Publications (Middle East) FZE was subjected to Post-qualification for a careful examination, validation and verification of all the eligibility, technical and financial requirements submitted, and was likewise found responsive with all the requirements, thus "post -qualified". A copy of the Post-Qualification Report is hereto attached, marked as **Annex "D"**, and made an integral part hereof;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare **Durga Das Publications (Middle East) FZE** as the **Single Rated and Responsive Bidder (SRRB)** and award the contract for the procurement of **Tourism Destination Marketing Company for Middle East/Gulf Cooperation Council** with a **monthly professional fee of Eight Thousand Five Hundred US Dollars (US\$8,500.00)** or a **total contract price of Forty-Two Thousand US Dollars (US\$42,500.00)** or its equivalent in Philippine Pesos, inclusive of applicable taxes for the period of August to December 2020;
- b) To recommend for approval by the Secretary of the Department of Tourism the foregoing findings.
