



**BAC Resolution Declaring Single Rated and Responsive Bid (SRRB)
and Recommending Award for the Procurement of a
"Tourism Destination Marketing Company for Thailand"
(DOT-BAC REI No. 2020-007)**

Resolution No. 2020- 145

WHEREAS, pursuant to approved Department of Tourism (DOT) Bids and Awards Committee (BAC) Resolution No. 2020-131 dated 07 August 2020, **SIAM Tourism Group Company Limited**, being the Single Rated Bidder (SRB) for the procurement of a "Tourism Destination Marketing Company for Thailand", was invited for the Opening of the Financial Proposal and Negotiation on 17 August 2020 and 18 August 2020, respectively, pursuant to the Competitive Bidding – Quality-Based Evaluation (QBE) procedures of Republic Act No. 9184 (RA 9184) and its 2016 Implementing Rules and Regulations (IRR). A copy of the approved BAC Resolution No. 2020-131 and the Invitation to the Opening of Financial Proposal and Negotiation sent to the SRB are hereto attached, marked as **Annex "A"** and **Annex "B"**, respectively, and are made integral parts hereof;

WHEREAS, during the Opening of the Financial Proposal, **SIAM Tourism Group Company Limited** offered a bid price amounting to Forty Thousand US Dollars (USD 40,000.00) (at Eight Thousand US Dollars [USD 8,000.00] per month), or its equivalent in Philippine Peso, for a period of five (5) months, inclusive of all applicable taxes. The said amount is within the ABC, thus declared "passed" in the Financial Proposal. Consequently, **SIAM Tourism Group Company Limited** proceeded with the negotiation stage;

WHEREAS, the DOT and SIAM Tourism Group Company Limited have successfully completed the negotiations, with the following agreements:

- *Contract duration be adjusted to cover the remaining months of the year, reckoning from the issuance of the Notice to Proceed. Effectively, this shall be four (4) months, from 1 September 2020 to 31 December 2020, with a total contract price of USD 32,000.00 (at USD 8,000.00 per month), or its equivalent in Philippine Peso, inclusive of all applicable taxes;*
- *Intelligence Report will be on a daily or weekly basis;*
- *Awareness Campaign in English Translation; and*
- *Presentation on the Zoom Tuesday Club*

These agreements shall form part of the final contract agreement. A copy of the Minutes of the Negotiation Meeting is hereto attached, marked as **Annex "C"**, and made an integral part hereof;

WHEREAS, after having successfully completed the negotiation, the Bid of SIAM Tourism Group Company Limited was subjected to Post-qualification for a careful examination, validation, and verification of all statements made in the eligibility, technical and financial requirements submitted, and was likewise found responsive, thus "post -qualified". A copy of the Post-Qualification Report is hereto attached, marked as **Annex "D"**, and made an integral part hereof;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare **SIAM Tourism Group Company Limited** as the **Single Rated and Responsive Bidder (SRRB)** and **award the contract** for the procurement of **Tourism Destination Marketing Company for Thailand** with a **monthly professional fee of Eight Thousand US Dollars (USD 8,000.00)** or a **total contract price of Thirty-Two Thousand US Dollars (USD 32,000.00)**, or its equivalent in **Philippine Pesos**, inclusive of **applicable taxes for the period of 01 September to 31 December 2020**;
- b) To recommend for approval by the Secretary of the Department of Tourism the foregoing findings.
