3. On - site support shall be provided by the manufacturer on the Next Business Day after final remote diagnosis for delivered items within Metro Manila and 3 days outside Metro Manila

- 4. On site support engineers and technicians should carry a valid manufacturer's ID and certification from the brand or manufacturer of the delivered ICT equipment especially on desktop, laptop and servers.
- Unit model must be current and not in "end of Life" as reflected in the current product line found in the manufacturer's official website / brochure. A manufacturer's certificate for this purpose is required.
- Certification from the brand and product manufacturer that the brand and product parts being offer will be available and serviceable for at least five (5) years after delivery and acceptance.
- 7. All components must conform to international standards and should be factory installed with corresponding part number and verifiable via web.
- 8. The manufacturer brand should be in the top three (3) in international data corporation (IDC) for the Q4 2018.
- The manufacturer brand must have at least two <u>warehouse/</u> <u>depot with readily available</u> <u>spare parts.</u>
