E. Section VI Technical Specifications

#5. Supplier must be FDA accredited. All vaccines should have Certificates of Product Registration from the FDA <u>as well as proof of WHO Prequalification.</u>
#6. <u>Expiration dates must not be less than 24 months from the first delivery date for Hepatitis B and Tetanus Toxoid vaccines.</u>
#10. <i>Below is the recommended timeline of activities for the conduct of the Vaccination Program.</i>

Activity:

Screening Test (HBsAg)

To be done on the first day of the first dose of Hepatitis B vaccine

Vaccination Days

Hepatitis Vaccination Day 1 (**x 5 working days**) – Hepatitis B Vaccine (1st Dose)

Hepatitis Vaccination Day 2 (**x 5 working days** – 1 month after 1st dose) – Hepatitis B Vaccine (2nd Dose)

Anti-Tetanus Vaccination Day (**x 5 working days** – 1 month after the 2nd dose of Hepatitis B vaccine) –
Tetanus Toxoid (One dose only)

Hepatitis Vaccination Day 3 (**x 5 working days** – 6 months after the 1st dose) – Hepatitis B Vaccine (3rd
Dose)

*The specific dates of immunization and screening test shall be agreed upon by the provider
and the Head Office and Regional Offices.*

NOTE: Payment for the Hepatitis B vaccines will be based on the results of the screen
test for Hepatitis B (HBsAG)
