Contract for the Procurement of Consulting Services for the Local Media Plan and Placements for Tourism Branding

This *Contract for the Procurement of Consulting Services for the Local Media Plan and Placements for Tourism Branding* ("Agreement") is made and entered into this ____ day of DEC 17 2020 between:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office at New DOT Building, 351 Sen. Gil Puyat Avenue, Makati City, represented by its **Secretary, BERNADETTE ROMULO-PUYAT** ("Entity");

and

IPG MEDIABRANDS PHILIPPINES, INC., a private entity with business address at Unit 2901 The Trade and Financial Tower, 7th Avenue corner 32nd Street, Bonifacio Global City, Taguig City, represented by its **Chief Financial Officer, MS. NENITA P. SAMSON** ("Consultant");

Each a "Party" and collectively, the "Parties"

WITNESSETH:

WHEREAS, the Entity is mandated to be the primary planning, programming, coordinating, implementing, and regulatory government agency in the development and promotion of the tourism industry, both domestic and international;

WHEREAS, pursuant to this mandate, the Entity seeks to implement a domestic tourism marketing campaign through local media placements targeted at domestic market and local travellers;

WHEREAS, the Entity needs to engage the services of consultant to formulate a local media plan and implement local media placements to promote domestic tourism;

WHEREAS, the Bids and Awards Committee (BAC) of the Entity, through **BAC Resolution No. 2020-192**, has declared the Consultant to be the Highest Rated and Responsive Bidder (HRRB) following a competitive bidding procedure for the procurement of consulting services for the Local Media Plan and Placements for Tourism Branding with a contract duration of five (5) months effective from the receipt by the Consultant of the Notice to Proceed;

WHEREAS, pursuant to the abovementioned BAC Resolution, the Entity has accepted the bid of the Consultant for **Fifty-Eight Million Five Hundred Seventy-Seven Thousand Seven Hundred Thirty-Five Pesos and 50/100 (PhP58,577,735.50)**, inclusive of all applicable taxes;

NOW, THEREFORE, based on the foregoing, the Parties agree as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

- (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from Procuring Entity's bid evaluation;
- (h) Eligibility requirements, documents and/or statements;
- (i) Performance Security;
- (j) Notice of Award of Contract and the Bidder's conforme thereto;
- (k) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.

4. The Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
