

Contract for the Procurement for the Services of an Event Management Company for the 2nd Philippine Education Tourism Conference 2022

This Contract for the Procurement for the Services of an Event Management Company for the 2nd Philippine Education Tourism Conference 2022 ("Agreement") is made this 16 December 2021, in the City of _____, by and between:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office address at the DOT Building, No. 351 Sen. Gil Puyat Avenue, Makati City, Philippines, represented by its **UNDER-SECRETARY WOODROW C. MAQUILING, JR.**, and hereinafter referred to as the "PROCURING ENTITY";

-and-

BCB EVENTS AND MARKETING MANAGEMENT INC. a private entity duly organized and existing under the laws of the Philippines, with business address at Lot 3, Blk. 4, Santan, Cainta, Rizal authorized and represented herein by its **MANAGING DIRECTOR JULIET S. MORALES** and herein referred to as the "SUPPLIER";

WITNESSETH:

WHEREAS, Republic Act No. 9593 or the Tourism Act of 2009 mandates the PROCURING ENTITY to provide an integrated market development program to attract people to visit the Philippines and enhance the prestige of the country and the Filipino people in the international community;

WHEREAS, pursuant to the above mandate the PROCURING ENTITY will conduct the Second (2nd) Philippine Education Tourism Conference ("PETC 2022") in Clark, Pampanga from 26 to 28 January 2022 through virtual and live platforms to feature new education tourism products and education tourism destinations.

WHEREAS, the PROCURING ENTITY needs to engage the services of an event company that will handle the requirements and related activities in the conduct of the PETC 2022;

WHEREAS, the SUPPLIER has submitted its bid for the Procurement for the Services of an Event Management Company for the 2nd Philippine Education Tourism Conference 2022, and the Bids and Awards Committee (BAC) of the PROCURING ENTITY, through **BAC Resolution No. 248** has declared the SUPPLIER to be the Single Calculated and Responsive Bid (SCR);

WHEREAS, pursuant to the abovementioned BAC Resolution, the PROCURING ENTITY has recommended the award of the contract to the SUPPLIER in the amount of **Five Million Four Hundred Fifteen Thousand Pesos (PhP5,415,000.00)** ("Contract Price") with a delivery period within two (2) months from receipt of the Notice to Proceed;

NOW, THEREFORE, based on the foregoing, the Parties agree as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement:

- a) The Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - b) the Schedule of Requirements;
 - c) the Technical Specifications;
 - d) the General Conditions of Contract;
 - e) the Special Conditions of Contract;
 - f) the Performance Security; and
 - g) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
 4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


