**Contract for the Procurement of Services of an Events Management Company  
for the Anilao Underwater Shootout 2021 Events and Collaterals**

This Contract for the Procurement of Services of an Events Management Company for the Anilao Underwater Shootout 2021 is made this NOV 26 2021 2021, in the City of Makati, by and between:

The **DEPARTMENT OF TOURISM (DOT)**, a government agency with principal office address at the DOT Building, No. 351 Sen. Gil Puyat Avenue, Makati City, Philippines, represented by its **OIC-UNDERSECRETARY, VERA ESMERALDA C. BUENSUCESO** and hereinafter referred to as the "PROCURING ENTITY";  
and

**BCB EVENTS AND MARKETING MANAGEMENT, INC.**, a private entity duly organized and existing under the laws of the Philippines, with business address at Lot 3 Blk 4 Santann St., Greenwoods Subd., Cainta, Rizal, duly authorized and represented herein by its **MANAGING DIRECTOR, JULIET S. MORALES** and herein referred to as the "SUPPLIER";

**WITNESSETH:**

**WHEREAS**, the PROCURING ENTITY is mandated to provide an integrated market development program to attract people to visit the Philippines and enhance the prestige of the country and the Filipino people in the international community;

**WHEREAS**, pursuant to this mandate, the PROCURING ENTITY will conduct the Anilao Underwater Shootout 2021 to attract professional and amateur underwater photographers to travel to Anilao, and to showcase the destination's readiness to accommodate divers and tourists;

**WHEREAS**, the PROCURING ENTITY is in need of services of an events management company to handle event set-up, talent and judge management, and event collateral production for the Anilao Underwater Shootout 2021 from **30 November 2021 to 5 December 2021** in Anilao, Batangas;

**WHEREAS**, the SUPPLIER has submitted its bid for event management services in the amount of **One Million Three Hundred Thirty-Seven Thousand Eight Hundred Eighty-Four Pesos and 95/100 (PHP1,337,884.95)**, inclusive of applicable taxes;

**WHEREAS**, after evaluation of the bid of the SUPPLIER, the Bids and Awards Committee (BAC) of the PROCURING ENTITY, through **BAC Resolution No. 2021- 213** has declared the SUPPLIER to be the bidder with the Single Calculated and Responsive Bid (SCRB), and has recommended the award of the contract to the SUPPLIER;

**NOW, THEREFORE**, based on the foregoing, the Parties agree as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement.:

- a. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications or Terms of Reference;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - c. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - d. Performance Security;
  - e. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - f. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract
3. In consideration for the sum of **One Million Three Hundred Thirty-Seven Thousand Eight Hundred Eighty-Four Pesos and 95/100 (PHP1,337,884.95)**, inclusive of applicable taxes, the SUPPLIER agrees to provide event management services in accordance with its Bid.
  4. The PROCURING ENTITY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




