**Contract for the Supply and Delivery of Two (2) Units of Brand New Motor Vehicle
for the Department of Tourism**

This *Contract for the Supply and Delivery of Two (2) Units of Brand New Motor Vehicle for the Department of Tourism* ("Agreement") is made this FEB 21 2022 2022, in the City of Makati, by and between:

The **Department of Tourism (DOT)**, a government agency with principal office address at the DOT Building, No. 351 Sen. Gil Puyat Avenue, Makati City, Philippines, represented by its **OIC-UNDERSECRETARY CHRISTOPHER V. MORALES.**, and hereinafter referred to as the "PROCURING ENTITY";
and

TOYOTA BATANGAS CITY, INC., a private entity duly organized and existing under the laws of the Philippines, with business address at Sitio 6, Diversion Road, Balagtas, Batangas City, duly authorized and represented herein by its **GENERAL MANAGER, MS. BRENDA MARY V. RAULE** and herein referred to as the "SUPPLIER";

WITNESSETH:

WHEREAS, the PROCURING ENTITY, in the implementation of its mandated, needs two (2) units of brand new motor vehicles (the Brand New Motor Vehicles") to transport personnel/visitors for activities related to education, tourism, trade and investment promotions, banking and finance, foreign affairs and other official functions;

WHEREAS, the PROCURING ENTITY is in need of a supplier of motor vehicles to provide and deliver motor vehicles in accordance with the required technical specifications;

WHEREAS, the SUPPLIER has submitted its bid for the Supply and Delivery of Two (2) Units of Brand New Motor Vehicle for the Department of Tourism in the amount of **Two Million Six Hundred Eighteen Thousand Philippine Pesos (PhP2,618,000.00)** inclusive of all taxes ("Contract Price"), and with a delivery period of sixty (60) calendar days from receipt of Notice to Proceed;

WHEREAS, after due evaluation of the bid of the SUPPLIER, the Bids and Awards Committee (BAC) of the PROCURING ENTITY, through **BAC Resolution No. 2022-011**, has declared the SUPPLIER to be the Lowest Calculated and Responsive Bid (LCRB) and has recommended the award of the contract for the SUPPLIER;

NOW, THEREFORE, based on the foregoing, the Parties agree as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;

- ii. Technical Specifications or Terms of Reference;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - c. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the PROCURING ENTITY's bid evaluation;
 - d. Performance Security;
 - e. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - f. Other contract documents that may be required by existing laws and/or the PROCURING ENTITY concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract
3. In consideration for the sum of **Two Million Six Hundred Eighteen Thousand Philippine Pesos (PhP2,618,000.00), inclusive of applicable taxes**; or such other sums as may be ascertained, SUPPLIER, agrees to provide the goods and services in accordance with its Bid.
4. The PROCURING ENTITY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
