The Department of Tourism – Bids and Awards Committee (DOT-BAC), invites PhilGEPS registered service providers to bid for the hereunder project:

Name of Project:	Procurement of a Service Provider for the Management and Operations of the Arrival/Departure Cards Processing Center
Brief description of the Project:	Services of a company engaged in the business that manage and operate the Arrival/Departure Cards Processing Center
Approved Budget for the Contract:	Sixteen Million Four Hundred Thousand Philippine Pesos (PhP16,400,000.00) inclusive of all applicable taxes
Contract Duration:	March to December 2020

Prospective bidders should have experience in undertaking a similar project within the last three (3) years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.


