INVITATION TO BID (IB)

The Department of Tourism - Bids and Awards Committee (DOT-BAC), invites PhilGEPS registered suppliers/contractors to bid for the hereunder project:

Name of Project: **PROCUREMENT OF GASOLINE, DIESEL FUELS, LUBRICANTS AND OTHER SERVICES (FUEL CARD PROGRAM) FOR THE DEPARTMENT OF TOURISM CENTRAL OFFICE FLEET OF VEHICLES**

Brief description of the Project: To provide the DOT-Central Office vehicle end-users and drivers with an efficient, secured, convenient, continuous and steady supply of petroleum products and services, which must be economically manageable.

Approved Budget for the Contract: **Five Million Seventy Thousand Five Hundred Sixty-One Philippine Pesos and Thirty-Six Centavos (PhP 5,070,561.36), inclusive of taxes, chargeable against 2020 funds. This project is subject to "early procurement short of award".**

Contract Duration: **April to December 2020**

Prospective bidders should have experience in undertaking a similar project within the last three (3) years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Check, Preliminary Examination of Bids, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

Likewise, the DOT may waive any minor defect therein and accept the offer most advantageous to the government.
