INVITATION TO BID (IB)

The Department of Tourism - Bids and Awards Committee (DOT-BAC), invites PhilGEPS registered suppliers/contractors to bid for the hereunder project:

Name of Project:	PROCUREMENT FOR THE PHYSICAL WAREHOUSING/STORAGE REQUIREMENTS FOR THE DEPARTMENT OF TOURISM (DOT)
Brief description of the Project:	To acquire services of a third-party service provider to meet the storage/physical warehousing requirements of the Department of Tourism – GSD and OTDPRIM
Approved Budget for the Contract:	Lot 1 - One Million One Hundred Fifteen Thousand Eight Hundred Thirty-Five Philippine Pesos (PhP 1,115,835.00) Lot 2 – Three Hundred Thirty-Seven Thousand Five Hundred Philippine Pesos (PhP 337,500.00) In the sum of One Million Four Hundred Fifty-Three Thousand Three Hundred Thirty-Five Philippine Pesos (PhP1,453,335.00), inclusive of taxes, chargeable against 2020 funds. This project is subject to “early procurement short of award”.
Contract Duration:	March to December 2020

Prospective bidders should have experience in undertaking a similar project within the last three (3) years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary “pass/fail” criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Check, Preliminary Examination of Bids, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

Bids shall be submitted in sealed envelopes labeled Technical Envelope and Financial Envelope addressed to the undersigned.

Likewise, the DOT may waive any minor defect therein and accept the offer most advantageous to the government. Further, the DOT assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of the bid.
