#### Description

Scope and Background: This project will cover the conduct of RT-PCR Swab Test for the personnel of Tourism Regulation, Coordination and Resource Generation (HCIDP, OIMD, OTSR), Officials/Regional Directors/Officers-In-Charge and the invited resource speakers who will be physically present during the conduct of the Executive Course on the National Accommodation Standards in the New Normal for the Regional Directors and Officers-in-Charge. As the country is still under the State of Public Health Emergency, a negative RT-PCR test result for COVID-19 is a requirement by some LGUs prior to entry to their locality.

#### Minimum Requirement for Bidders:

Must be Department of Health (DOH) accredited and/or partnered with DOHaccredited testing facilities. A proper documentation of accreditation must be shown.

Has duly trained licensed medical practitioners (Medical Technologists, Nurses, or Doctors) to administer the test

Must be willing to provide services on a send bill arrangement

Duration: November – December 2021

#### Deliverables

The service provider shall:

Be responsible in administering nasopharyngeal or oropharyngeal swab (RT-PCR) testing to determine active infection of COVID-19;

Ensure that the use of personal protective equipment by the medical practitioners is observed at all times;

Be Capable of providing the following testing arrangements in the comfort and safety of own homes/home service or private vehicle (Drive-thru) within Metro Manila for the first RT-PCR test, and second test will be conducted before departure of the Tourism Regulation, Coordination and Resource Generation (HCIDP, OIMD, OTSR) personnel, Officials/Regional Directors/Officers-In-Charge and the invited resource speakers in Tagaytay-Batangas (venue or nearest testing center in TagaytayBatangas);

Ensure that no additional fees and extra cost of test/kits shall be charged or collected from the employees who will be tested. Package includes the testing, certificate, administration/transportation fees, and VAT; and

Be able to release the RT-PCR test results within 1-2 days prior of travel.
