#### Description

##### Objectives:

1. Test the effectiveness of the Site and Product Development Guidebook being developed;
2. Identify gaps on the concepts provided in the guidebook;
3. Conduct assessment of existing and possible tourism circuits in South Palawan; and
4. Make recommendations to further improve procedures for the creation of circuits as identified in the Guidebook

##### Scope of Service

The service provider should be able to provide the accommodation, meals transportations, transfers, RT- PCR Test and antigen services, meeting venue and load cards with the following specifications:

##### A. General Requirements

- Service Provider should be a DOT-Accredited Tour Operator
- Inclusive Date: October 25 to 29, 2021
- Amenable to send-bill arrangement/government procedure
- Price quotation should be denominated in the Philippine Peso and inclusive of 12% VAT and all other applicable taxes and charges. Price validity shall be for a period of one hundred twenty (120) calendar days.
- Tour Operator must be based in Region IVB (MIMAROPA)

1. Mayor's/Business Permit
2. Proof of PhilGEPS Registration
3. Omnibus Sworn Statement
4. DOT Accreditation Certificate

#### C. Specific Requirements

##### C.1 Transportation (Airfare)

- Airline with round-trip flight to Manila and Puerto Princesa City good for four (4) pax (October 25 to 29, 2021).

##### C.2 Transportation (Van Rental)

- Air-conditioned van with stored supplies of Alcohol with 70% Solution (1 gallon for 6 pax), Mask (Surgical Face Masks), Travel Paper Soap, Insect repellent, wet wipes and Tissue good for 6 pax for a period of 5 days,
- Drivers must have negative anti-gen test result prior travel; and
- Must conform to the following itinerary:

Whole day one (1) van rental (10 hours) within PPC and South Palawan (PPC, Narra, Brooke's Point, Bataraza and Balabac) x 5 days

##### C.3 Transportation (Boat Rental)

- Roundtrip boat from Bataraza to Balabac

##### C.4 Accommodation and Meals

Single room accommodation for 6 pax for 4 nights inclusive of meals breakfast, lunch and dinner

##### a. RT-PCR and AntigenTest

- RT-PCR Test for four (4) pax by a DOH-Accredited Facility 48 hours prior travel
- Antigen Tests for 6 pax in the Municipalities to be visited
