- Tour Operator must be based in NCR or Region IVB (MIMAROPA)

##### C.1 Transportation (Airfare)

- Roundtrip airline tickets of Manila and San Jose, Occidental Mindoro good for two (2) pax (August 15 and 19, 2022) with 20kgs baggage allowance per pax

##### C.2 Transportation (Van Rental)

- Air-conditioned van with stored supplies of face mask, face shield, and alcohol (sanitation kits);
- Must conform to the following itinerary:

Whole day one (1) van rental (10 hours) within Mindoro Island (San Jose, Magsaysay, Bulalacao, and Mansalay) x 4 days

##### C.3 Accommodation

- Must be DOT-Accredited Accommodation Establishment
- Must provide single or twin-sharing occupancy room accommodation for the following:

August 15 - 19, 2022 5D4N (2 pax)

- Must have a stable WIFI connection
- Must have a 24-Hour Security

- Breakfast, Lunch, Dinner, and AM and PM snacks good for 4 days for two (2) persons (August 15 - 19, 2022)

##### C.5 Courier Fee for Care Kits

- Eighty kilograms (80kgs) of courier to ship at to San Jose, Occidental Mindoro
