#### Description

##### Objectives:

1. Assess and inspect tourism sites of Marinduque in preparation of its re-opening
2. Conduct LGU and Stakeholders Dialogue with the DOT Secretary
3. Award DOT-DOLE Beneficiaries

##### Scope of Service

The service provider should be able to provide the meals, transportations, transfers, accommodation, and load cards with the following specifications:

#### A. General Requirements

- Service Provider should be a DOT-Accredited Tour Operator
- Inclusive Date: May 18 – 23, 2021
- Amenable to send-bill arrangement/government procedure
- Price quotation should be denominated in the Philippine Peso and inclusive of 12% VAT and all other applicable taxes and charges. Price validity shall be for a period of one hundred twenty (120) calendar days.
- Tour Operator must be based in NCR or Region IVB (MIMAROPA)

#### B. Documentary Requirements

1. Mayor's/Business Permit
2. Proof of PhilGEPS Registration
3. Omnibus Sworn Statement
4. DOT Accreditation Certificate

#### C. Specific Requirements

##### C.1 Transportation (Van and Boat Rental)

- Air-conditioned van (at least 12-seater) with stored supplies of face mask, face shield, and alcohol (sanitation kits);
- 2-day Boat Hire Sta Cruz Proper (Polo-Maniwaya Island)
- Drivers must have a negative anti-gen test result prior travel; and
- Must conform to the following itinerary:

Manila – Talao-Talao Port – Marinduque (May 18, 2021) x 2 vans  
Marinduque – Talao-Talao Port – Manila (May 23, 2021) x 2 vans  
Whole day van rental (10 hours) within Marinduque x 6 days x 2 vans  
Back-up van rental (10 hours) within Marinduque x 2 days x 1 van  
(May 21 and 22, 2021)  
Whole day boat rental (Polo-Maniwaya Island) x 3 boats  
(May 19 and 22, 2021)

##### C.2 Meals

Requirements for meals shall include the following:

- Breakfast, Lunch, Dinner good for 6 days for nine (9) persons (May 18 – 23, 2021)
- Breakfast, Lunch, Dinner good for 2 days for four (4) persons (May 21 – 22, 2021)
- AM Snacks for 65 pax on May 21, 2021
- AM Snacks for 25 pax on May 22, 2021

##### C.3 Load Card

- Four (4) Php 300.00 load card for the project officers

##### C.4 Accommodation

- Must be DOT-Accredited Accommodation Establishment
- Must provide room accommodation for the following:

May 18 – 23, 2021 6D5N (9 pax)  
May 21 – 22, 2021 2D1N (3 pax)

- Must have a stable WIFI connection
- Must have a 24-Hour Security
- Must have an In-house restaurant

#### C.5 RT-PCR Test

- RT-PCR Test for 9 (nine) pax by a DOH-Accredited Facility 1-2 days prior travel
