Background

Tourism is considered to be a top priority in developing a certain country. All over the globe, it is viewed as a leading industry and a key driver for economic development. It contributes through foreign-exchange receipts, provides employment opportunities and serves as an income-generating mechanism.

Over the last years, in its continuous collaboration with its global partners, the Philippines through the Philippine Department of Tourism (PDOT) have forged almost 30 Memorandum of Understanding on Tourism Cooperation with various countries which focuses on the areas of tourism development planning, marketing and promotions, human capital development, tourism standards and regulations and tourism investment.

Objective

The Department of Tourism through the Office of Tourism Development Planning, Research and Information Management - Policy Formulation and International Cooperation Division (OTDPRIM-PFICD) will formulate a Tourism Comparative Study on International Tourism Cooperation as part of its mandate under the Tourism Act of 2009 or also known as R.A 9593 is to: 1) Pursue, together with the appropriate offices, the Department's interests in multilateral, international and regional as well as bilateral tourism cooperation, agreements and treaties; and 2) Develop strategic plan on enhancing the benefits and gains as well as strengthen the institutional mechanism to carry out the arrangements for agreed cooperation and treaties.

- e. continuous development on certain undertakings, commitments, programs, and activities concerning exchange of professionals in the field of tourism.

This study shall serve as a primary mechanism for the Philippines to undertake a high-level bilateral engagement with other countries, as well as to identify its quality partners in the international tourism community.

Also, this study is developed to provide information and serve as an inventory on the country's strengths and weaknesses on tourism industry, which shall lead to the development and improvement of its management.
