TERMS OF REFERENCE

I. PROJECT TITLE : Thai International Education Consultants Association (TIECA) Familiarization Tour

V. BACKGROUND :

To provide the agents complete understanding of Philippine ESL, the OPMD-ESL conducted a familiarization tour for ten TIECA agents from 19 to 24 May 2018, which covered Cebu and Bohol. The activity provided information on ESL programs, school facilities, curriculum, quality of teachers, and tuition and other fees. Fun components were also included to showcase the Philippines as a tourism destination as well.

VI. PURPOSE/OBJECTIVES :
