

# SUPPLEMENTAL/BID BULLETIN NO. 1

This Supplemental/Bid Bulletin is issued to all prospective bidders to clarify, modify and/or amend items in the Bidding Documents as discussed and agreed during the Pre-Bid Conference held on 26 February 2021 for the **Procurement of DOT Janitorial Services (DOT-BAC-IB No. 2021-002)**.

11. The Service Provider shall provide the required uniforms and identification cards (ID) to all janitorial service personnel. It shall be neat and worn properly at all times by the service personnel during the performance of their obligations. In addition, due to the COVID-19 pandemic, all personnel are likewise required to wear a minimum personal protective equipment, such as facemasks and faceshields.

- 1. The bidders were also informed that a total of 313 days should be factored in computing the total bid price.
- 2. One (1) Original and five (5) copies will be required for the submission of proposals.

- 3. In case of tie or when two (2) or more bidders are determined and declared as Lowest Calculated and Responsive Bid (LCRB), the DOT BAC shall follow the Guidelines on the use of Non-discretionary/Non-discriminatory Selection criteria as Tie-breaking Method issued by the GPPB thru Circular No. 06-2005.
