- 1) Bidders may just submit their valid PhilGEPS Platinum Certificate on the date of the bid opening in lieu of their *class A* documents.
- 2) If awarded for the project, bidders must submit a valid tax clearance, and proof of renewal for the expired mayor's permit during post-qualification.

All unamended portions of the Bidding Documents shall remain the same.
